An Act to amend the Constitution. 5

WHEREAS by virtue of Article 46 of the Constitution any provision of the Constitution may be amended in the manner provided by that Article:

AND WHEREAS it is proposed to amend Articles 13 and 16 of the Constitution:

Be it enacted by the Oireachtas as follows:

Amendment of Article 13 and 16 of the Constitution 10

1. The following Articles of the Constitution are hereby amended as follows:

(a) in Article 13—

(i) section 2.1 of both the Irish text and the English text shall be repealed,

(ii) section 2.2 and 2.3 of both texts shall be numbered as section 2.1 and 2.2 respectively. 15

(b) in Article 16—

(i) section 3.1 of both the Irish text and the English text shall be repealed,

(ii) section 3.2 of both texts shall be numbered as section 3,

(iii) section 5 of both the Irish text and the English text shall be repealed,

(iv) the section, the text of which is set out in *Part 1* of the *Schedule* to this Act, shall be inserted before section 6 of the Irish text, 20

(v) the section, the text of which is set out in *Part 2* of the *Schedule* to this Act, shall be inserted before section 6 of the English text.

(iii) aisghairfear alt 5 den téacs Gaeilge agus den téacs Sacs-Bhéarla araon,

(iv) cuirfear an t-alt a bhfuil an téacs de leagtha amach i *gCuid 1* den *Sceideal* a ghabhann leis an Acht seo isteach roimh alt 6 den téacs Gaeilge, 20

(v) cuirfear an t-alt a bhfuil an téacs de leagtha amach i *gCuid 2* den *Sceideal* a ghabhann leis an Acht seo isteach roimh alt 6 den téacs Sacs-Bhéarla.

2. (1) The amendments of the Constitution effected by this Act shall be collectively known as, and may for all purposes be collectively referred to as, the Thirty-fifth Amendment of the Constitution.
- (2) This Act may be cited as the Thirty-fifth Amendment of the Constitution (Fixed 5
Period for the Duration of Dáil Éireann) Act 2015.

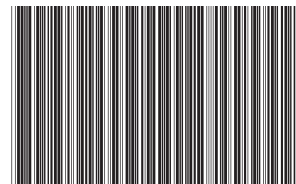
